

# Regulations for Reservations and Stay at Weranda Houses

## 1. Personal Data Protection (GDPR)

As of May 25, 2018, the Regulation of the European Parliament and of the Council (EU) 2016/679 of April 27, 2016 on the protection of natural persons with regard to the processing of personal data (GDPR) entered into force.

1. The administrator of your data is "**IVA**" **Iwona Tomas**, registered office: ul. Szczecińska 16, 73-108 Morzyczyn, NIP: 854-167-77-70.
2. Your data is processed in connection with the provision of our services, for promotional purposes, and to enable contact with you.
3. You have the right to access your data, rectify it, delete it, restrict processing, object to processing, as well as the right to data portability.
4. You may withdraw your consent to data processing at any time (withdrawal does not affect the lawfulness of processing carried out before withdrawal).
5. Your data is not transferred outside the European Economic Area.
6. You have the right to lodge a complaint with the supervisory authority (President of UODO).

8. The privacy policy is available at the property's reception.

## 2. Reservation Rules

1. The year-round house is intended for a maximum of **6 people**. Smoking is strictly prohibited inside (allowed on the terrace). In case of **violation of the no-smoking rule** inside the house, a **fee of 500 PLN will be charged**.
2. In the event of exceeding the number of persons not declared at the time of reservation, the owner has the right to terminate the agreement without a refund.
3. Reservations must be made by phone (**+48 91 404 0702**) or by email (**info@weranda.apartments**).
4. The price includes: breakfast, parking, bed linen, towels, a coffee and tea set, toiletries in the bathroom.
5. The reservation requires a **deposit of 50%** of the total stay value. The deposit is non-refundable.
6. Failure to pay the deposit on time = cancellation of the reservation.
7. Payment for the accommodation: in cash or by card, on the day of arrival.
8. Refundable **deposit: 600 PLN** (payable in cash upon check-in).
9. The hotel day lasts **from 3:00 p.m. on the day of arrival until 11:00 a.m. on the day of departure**.
10. In exceptional situations, the owner reserves the right to change the house number.

### 3. Stay Rules

1. Guests are obliged to maintain the cleanliness of the house and the property area.
2. Quiet hours are **from 10:00 p.m. to 6:00 a.m.**
3. A fee of **50 PLN** will be charged for a lost key.
4. Kitchen appliances and dishes must be washed before departure.
5. It is forbidden to light bonfires, grill, use fireworks, or flammable materials.
6. The property is monitored.
7. The entrance gate is closed **from 10:00 p.m. to 6:00 a.m.**; guests receive a code.
8. The owner is not responsible for items left in the house or in vehicles.
9. In the event of a gross violation of the regulations, the owner may terminate the agreement without refund.

### 4. Rules for Staying with Animals

1. The stay of animals must be reported at the time of reservation. **Fee: 50 PLN/day/animal.**
2. The owner is obliged to fully control the animal.
3. A dog health booklet with up-to-date vaccinations is required.
4. The animal should relieve itself outside the house area.
5. The owner is obliged to clean up after their animal both inside and on the property grounds.
6. The owner is responsible for any damage caused by the animal.
